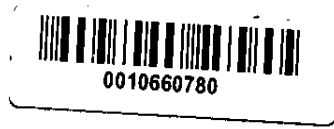

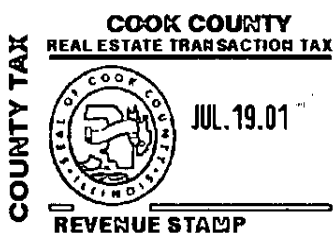

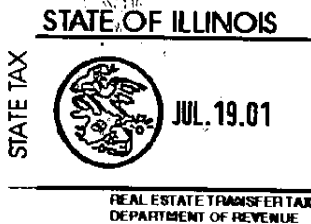
SUBJECT TO: general real estate tax for 2000 and subsequent years, covenants, conditions and restrictions of record, building lines and easements, if any.
