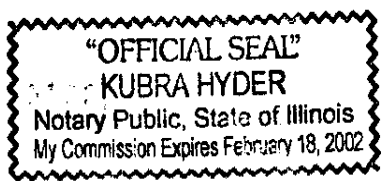

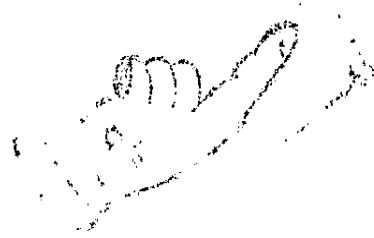


EXHIBIT "A"
