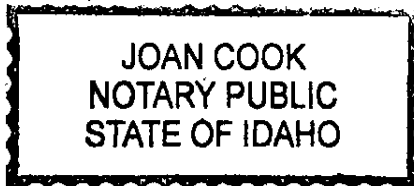

LEGAL DESCRIPTION FOLLOWS:

PARCEL I: That part of Lot 16, in Colony Lake Club, Unit Number 1, being a Subdivision of part of the East half of Northwest quarter of Section 16, Township 41 North, Range 10, East of the Third Principal Meridian, in the Village of Schaumburg, according to the plat thereof recorded December 30, 1976 as Document Number 23763577, described as follows:

Beginning at the Northwest corner of said Lot 16, thence Easterly along the Northerly line of said Lot 16, North 89 degrees 25 minutes 31 seconds East, a distance of 66.00 feet to a point of curvature, thence continuing Easterly along the said Northerly line, being a curved line convex to the North, of 344.90 feet in radius, for an arc length of 56.00 feet to the Northeast corner of said Lot 16, thence Southerly along the Easterly line of said Lot 16, South 21 degrees 02 minutes 52 seconds West, a distance of 52.03 feet, thence South 89 degrees 25 minutes 31 seconds West, a distance of 102.58 feet to a point on the Westerly line of said Lot 16, thence Northerly along the said Westerly line North 00 degrees 34 minutes 29 seconds West, a distance of 52.90 feet, to the point of beginning, all in Cook County, Illinois.
