### MORTGAGE

THIS MORTGAGE IS DATED JUNE 30, 2000, between DANIEL VOUSTROS and MARY ANNE VOUSTROS, 60638 (referred to below as HUSBAND AND WIFE, whose address is 6100S NEENAH, CHICAGO, IL "Grantor"); and OLD KENT BANK, whose address is 5235 WE'sT 63RD ST., CHICAGO, IL 60638 (referred to below as "Lender").

GRANT OF MORTGAGE. For valuable consideration, Grantor mortgages, warrants, and conveys to Lender all of Grantor's right, title, and interest in and to the following described real property, together with all existing or subsequently erected or affixed buildings, improvements and fixtures; all easements, rights of way, and appurtenances; all water, water rights, watercourses and ditch rights (including stock in utilities with ditch or jurigation rights); and all other rights, royalties, and profits relating to the real property, including without limitation all minerals, oil, gas, geothermal and similar matters, located in COOK County, State of Illinois (the "Real Property"):
