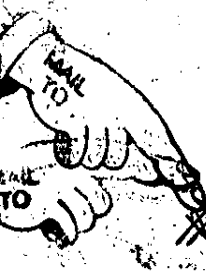

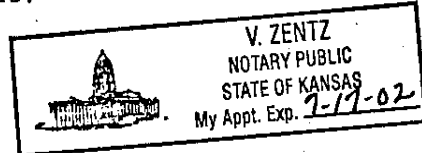

THIS MORTGAGE is made this 6th day of July, 2000, between the Mortgagor, LARRY MUSIAL, HUSBAND AND WIFE and LISA VIRRUSO-MUSIAL
