WHEREAS, the parties hereto for mutual consideration wish to revise the terms of the Note and Mortgage of said indebtedness;

NOW THEREFORE, in consideration of the mutual covenants contained herein, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

It is agreed that as of the date of this Modification, the unpaid principal balance of said indebtedness is One Hundred Three Thousand Two Hundred Five Dollars and 72/100 (\$103,205.72).

The Note and Mortgage dated June 26, 2000 shall be modified to provide for an additional advance of funds not to exceed the amount of Nine Hundred Fifty Dollars (\$950.00).

Mid America will fund an Additional Advance of Nine Hundred Fifty Dollars (\$950.00) which shall increase the unpaid principal balance of said indebtedness to One Hundred Four Thousand One Hundred Fifty Five Dollars and 72/100 (\$104,155 72).

The Borrowers do hereby amend and modify the Note and Mortgage described above by specifically amending Section 2 (Interest), Section 3 (Payments) and Section 4 (Interest Rate and Monthly Payment Changes) of the Note as follows:

As of June 1, 2001, the modified interest rate the Borrowers are required to pay will be 7.125%.

This modified interest rate will remain constant for the remaining term of the loan. The principal and interest payment based on the rate indicated above will be \$708.13. The Borrowers shall make the new modified payments on the first day of each month beginning on July 1, 2001.

It is agreed that all sums owed under the Note will re paid no later than July 1, 2030 ("the Maturity Date") and the Maturity Date under all the Loan Documents will be deemed July 1, 2030.
