- (f) Drainage ditches, feeders, laterals and drain tile, pipe, or other conduit.

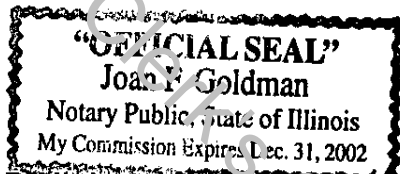
