
The undersigned Commissioner, duly appointed to make a true and impartial assessment of the cost of an improvement consisting of the excavation for and construction of watermains and a water distribution system in portions of Gaynelle Road, Mark Lane, James Street, Leslie Ann Drive, Beverly Avenue, Jody Lane and 167th Street in the Kimberly Heights Subdivision, and the improvements necessary to bring water to said subdivision; including all tools, machinery and equipment and all necessary material and labor necessary to complete the improvements and place them in operation; as provided for by a Resolution of the Board of Local Improvements and an Ordinance enacted by the corporate authorities of the municipality, said Ordinance having been passed on the 7th day of August, 2001, does hereby certify:

That he has completed the attached assessment roll showing a list of all the lots, blocks, tracts and parcels of land assessed for the proposed improvement; the amount assessed against each; the name of the person who paid the taxes on each parcel during the preceding year in which taxes were paid as shown upon the books of the County Collector; the residence of the person so paying the taxes where the same could be found; and the assessment having been divided into installments, the amount of each installment is stated.

He further certifies that he estimated what portion of the total cost of such improvement would be of benefit to the public and what portion thereof would be of benefit to the property to be benefitted and apportioned the same between the Village and such property so that each will bear its relative equitable proportion; the amount so estimated and apportioned to the Village as public benefit being the sum of \$177,860.00; and the amount so estimated and apportioned to the property to be benefitted being the sum of \$691,015.20; and having found such amounts the undersigned did apportion and assess the amount so found to be of benefit to the property upon the several lots, blocks, tracts and parcels of land in the proportion in which they will severally be benefitted by such improvement; and that no lot, block, tract or parcel of land has been assessed a greater amount than it will be actually benefitted.

AFFIDAVIT TO ROLL

MARVIN MAGER, being first duly sworn on oath, deposes and says that he has made a true and impartial assessment of the cost of the said improvement upon the property benefitted by such improvement; that he verily believes that the amounts assessed against the public and against each lot, block, tract and parcel of land assessed in the said assessment roll made by him in pursuance thereof, attached hereto, are just and equitable and do not exceed the benefits which will be in each case derived from said improvements; that no lot, block, tract or parcel of land has been assessed more than its proportionate share of the cost of said improvement.
