INCLUDING THE SIGNING OF ALL MORTGAGE DOCUMENTS AS REQUIRED BY NORTH COMMUNITY BANK.



4. This power of attorney shall become effective on its execution.


5. This power of attorney shall terminate on December 31, 2001.





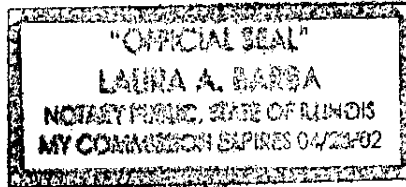
