
KNOW ALL MEN BY THESE PRESENTS, that Manharbhai F. Patel and Vinubhai R. Patel, hereinafter called First Party, in consideration of Ten Dollars (\$10.00) in hand paid, and of other good and considerations, the receipt acknowledged, does hereby assign, transfer and set over unto:
