That the Subordinator's Mortgage and any and all advances secured thereby, regardless of when such advances shall be made, or any renewal or extension or said Mortgage or advances, shall be and the same hereby are subject to and subordinate to the lien of the Lender's Mortgage, except that any future advances made by Lender pursuant to the Lender's Mortgage, other than advances made by Lender to protect its security interest in the property pursuant to Paragraph 7 of the Lender's Mortgage, shall be subordinate to the lien of the Subordinator's Mortgage.
- 2. That Borrower and Subordinator do hereby covenant and warrant that they have no assigned, conveyed or otherwise transferred their respective interest in the Property either on or prior to the date hereof to anyone
- 3. This agreement shall bind and inure to the benefit of the heirs, personal representatives, assigns and successors of the respective parties hereto.
