JUDGES DEED

WHEREAS, on the 18th day of July, 2001, in Case No. 01 M6 196<sup>3</sup> entitled *City of Harvey v. Elma and Sylvia Reutner, et al.*, the real estate herein below described was declared abandoned by this court. Plaintiff was granted a Judgment which was entered which said Judgment provided pursuant to 65 ILCS 5/11-31-1 that within 30 days of the notice, the owner of record should appear or any other person having an interest in the property file with the court a request to demolish the dangerous or unsafe building or to put the building in safe condition;

AND the said Defendants having failed to appear to file with the court a request to demolish the dangerous or unsafe building or to put the building in safe condition within the time prescribed by said Judgment,

AND said Judgment further providing that upon the failure of Defendants to appear as aforesaid; that a Judge of the Circuit Court of Cook County, Illinois, should execute such conveyance.

NOW THEREFORE, know all men by these present, that I, C. J. Donnelly, Judge of the Circuit Court of Cook, County, Illinois, in consideration of the premises, do hereby convey unto the said Plaintiff, City of Harvey heirs and assigns forever, the following described premises, to:

Lot 16 in block 61 in the Subdivision of blocks 56 to 61, both inclusive, in South Lawn, said South Lawn being a Subdivision of Section 17 and the South 1/2 of Section 8, Township 36 North, Range 14, East of the Third Principal Meridian, in Cook County, Illinois. Permanent Index Number 29-17-108-031.

TO HAVE and to hold the same, with all appurtenances thereto belonging, to the said City of Harvey heirs and assigns forever.

This Deed is executed and delivered solely in compliance with the Judgment hereinabove referred to.
