That said Contractor is entitled to credits on account thereof as follows, to wit: \$2,656.15 leaving due, unpaid and owing to the Claimant, after allowing all credits, the sum of \$35,451.73 for which, with interest and attorney's fees, the Claimant claims a lien against said Contractor and Owner on said land and improvements and on the money or other consideration due or to become due from the Owner under said contract.
