THIS SUBORDINATION AGREEMENT, made in the City of Chicago, State of Illinois this 9th day of July 2001 by LaSalle Bank, NA, a national banking association organized and existing under and by virtue of the laws of the United States of America, and doing business and State of Illinois ("Bank").

2. That this Agreement shall be binding upon and shall insure to the benefit of Mortgagee, its successors and assigns.
