**ORIGINAL CONTRACTOR'S CLAIM FOR LIEN**

The Claimant, Newcastle Limited LLC, an Illinois limited liability company ("Claimant") of 123 W. Madison, Chicago, Illinois, hereby files its Claim for Mechanics Lien on the Real Estate (as hereinafter described) and against the interest of AWE Properties LLC, an Illinois limited liability company, ("Owner"), and any person claiming an interest in the Real Estate by, through or under the Owner.

Claimant states as follows:

1. On and prior to May 23, 2000, Owner owned fee simple title to the real estate (including all land and improvements thereon) ("Real Estate") in Cook County, Illinois, commonly known as 1803-1995 Hicks Road, Rolling Meadows, Illinois and legally described as follows:

2. On or about May 23, 2000, Claimant entered into a contract with Hawthorn Management Co. under which Claimant agreed to provide construction supervision and management and supervision for the improvement to the Real Estate.

3. The Contract was entered into by Owner, and the work was performed and completed with the knowledge and consent of Owner. Alternatively, Owner authorized Hawthorn Management Co. to enter into the Contract or alternatively, the Owner knowingly permitted Newcastle Limited LLC to enter in the Contract for the improvement of the Real Estate.

4. As of the date hereof, there is due, unpaid and owing to Claimant, after allowing all credits, the principal sum of \$8,943.20 which principal amount bears interest at the statutory rate of 10% per annum. Claimant claims a lien on the Real Estate (including all land and improvements thereon) in the amount of \$8,943.20 plus interest pursuant to 770 ILCS 60/1.

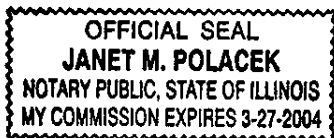
