Prior Security Interests. With regard to any other mortgage, deed of trust, security agreement or other lien document that created a prior security interest or encumbrance on the Property, Mortgagor agrees to make all payements when due and to perform or comply with all covenants. - 13. NOTICE. Unless otherwise required by law, any notice shall be given by delivering it or by mailing it by first class mail to the appropriate party's address on page 1 of this Security Instrument, or to any other address designated in writing. Notice to one mortgagor will be deemed to be notice to all mortgagors.
- 14. WAIVERS. Except to the extent prohibited by law, Mortgagor waives all appraisement and homestead exemption rights relating to the Property.
- 15. MAXIMUM OBLIGATION LIMIT. The total principal amount secured by this Security Instrument at any one time shall not exceed \$20,235.00. This limitation of amount does not include interest, attorneys fees, and other fees and charges validly made pursuant to this Security Instrument. CONDOMINIUM RIDER

THIS CONDOMINIUM RIDER is made this 22ND day of AUGUST, 2001, and is incorporated into and shall be deemed to amend and supplement the Mortgage, Deed of Trust or Security Deed (the "Security Instrument") of the same date given by the undersigned (the "Mortgagor/Grantor") to secure Mortgagor's/Grantor's Note to FIRST HOME MORTGAGE

(the "Lender") of the same date and covering the Property described in the Security Instrument and located at: 1355 WEST ARGULE UNIT 2B

The Property includes a unit in, together with an undivided interest in the common elements of, a condominium project known as: ANDI-CONVILLE ARBOR CONDOMINIUM

(the "Condominium Project"). If the owners association or other entity which acts for the Condominium Project (the "Owners Association") he id title to property for the benefit or use of its members or shareholders, the Property also includes Mortgagor's/Gramor's interest in the Owners Association and the uses, proceeds and benefits of Mortgagor's/Grantor's interest.

CONDOMINIUM COVENANTS. In addition to the covenants and agreements made in the Security Instrument, Mortgagor/Grantor and Lender further covenant and agree as follows:

Mortgagor/Grantor shall give Lender prompt notice of any lapse in required haz and insurance coverage.

In the event of a distribution of hazard insurance proceeds in lieu of restoration or reour following a loss to the Property, whether to the unit or to common elements, any proceeds payable to Mortgagor/Grantor are hereby assigned and shall be paid to Lender for application to the sums secured by the Security Instrume ut, with any excess paid to Mortgagor/Grantor.

- C. Public Liability Insurance, Mortgagor/Grantor shall take such actions as may be reasonable as insure that the Owners Association maintains a public liability insurance policy acceptable in form, amount, and extent of coverage to Lender.
- D. Condemnation. The proceeds of any award or claim for damages, direct or consequential, payable to Mortgagor/Grantor in connection with any condemnation or other taking of all or any part of the Property, whether
