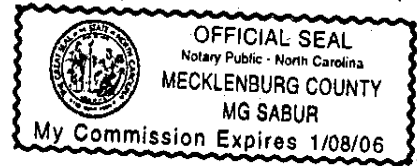

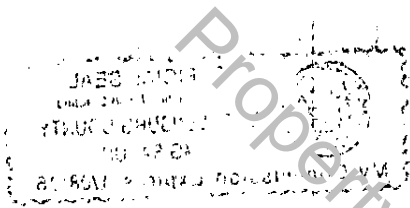

UNIT " B" (1834 Wilmot Ave.)
