CERTIFICATE OF CORRECTION

Joseph A. Schuch & Associates do hereby certify that they have surveyed and subdivided the RESUBDIVISION OF PART OF DYNASTY LAKE ESTATES UNIT V PHASE 1, being a Resubdivision in Dynasty Lake Estates Unit V Phase I, being a subdivision of part of the Northwest Quarter of Section 2, Township 35 North, Range 13 East of the Third Principal Meridian, according to the plat thereof recorded July 31, 2001 as Document 10691020, in Cook County, Illinois.

The 15.00 feet wide public utility and drainage easement shown at the rear (West Line) of Lots 72 through 76, all inclusive, and the 15.00 feet wide public utility and drainage easement shown at the rear (North Line) of Lots 76 through 79, all inclusive, should be corrected as follows:

Description of Corrected Easement Area

Beginning at the Northwest corner of said Resubdivision of Part of Dynasty Lake Estates Unit V Phase I, being the intersection of the South line of the North 468.00 feet of the Northwest Quarter of Section 2 and the Easterly 50.00 foot right-of-way line of Crawford Avenue (Pulaski Road) as dedicated; thence South 90°00'00" East 418.00 feet along the North line of said Resubdivision; thence South 29°44'37" East 46.07 feet; thence North 90°00'00" West 336.00 feet; thence South 30°00'00" West 88.42 feet; thence South 00°19'01" East 406.30 feet to the North right-of-way line of Carrington Drive as dedicated; thence South 89°40'59" West 60.00 feet along last said right-of-way line to the Easterly right-of-way line of Crawford Avenue (Pulaski Road) as dedicated; thence North 00°19'01" West along last said right-of-way line 523.21 feet to the Point of Beginning.
