#### Claimant states as follows:

- 1. On or about June, 2001, Owner owned fee simple title to the Real Estate, including all land and improvements thereon the ("Real Estate"), in Cook County, Illinois, commonly known as 1012 W. Diversey in Chicago Illinois.
- 2. Ability Construction & Remodeling Co. Inc. ("Contractor") is the general contractor for the improvements on the Real Estate
- 3. In June 2001, the Contractor made a Subcontract with Claimant under which Claimant agreed to provide all necessary labor and materials to Mount and finished Dry wall in all the building on the Real Estate in exchange for payment in the original contract sum of \$29,300.00 (the "Subcontract")
- 4. The subcontract was entered into by Contractor and the work performed by Claimant with the knowledge and consent of Owner. Alternatively, the Owner specifically authorized contractor and/or contractors agents to enter into contracts for improvements of the Real Estate. Alternatively, The Owner Knowingly permitted the Contractor to enter into contracts for the improvement of the Real Estate.
- 5. On August 27th, 2001, Claimant completed substantially the work required to be performed under the Subcontract and finished the detailing on the same day.
