Declaration of Restrictive Covenant

Whereas, it is the desire and intention of the Owner to impose on the Real Estate a restriction for the benefit of the residents of the Village of Brookfield, Illinois.

NOW THEREFORE the Owner hereby declares that the Real Estate legally described above is held and shall be held, hypothecated, encumbered, conveyed, leased, rented, used, occupied and improved subject to the following limitation(s), restriction(s), condition(s) and covenant(s), all of which are declared and agreed to be in furtherance of the intent and purpose of the Zoning Ordinance of the Village of Brookfield, Illinois and are established and agreed upon for the purpose of enhancing and protecting the value, character, desirability and compatibility of the adjoining and surrounding lands and property. Each and every limitation, restriction, condition and covenant shall run with the land and shall be binding on parties having or acquiring any right, title or interest in the described lands or any part thereof.

The existing detached garage structure has been increased in size up to a maximum of one hundred (100) additional square feet pursuant to the applicable provisions of the Village of Brookfield Zoning Ordinance. The existing detached garage structure as increased in size may be repaired or replaced in conformity with the applicable provisions of the Village of Brookfield Zoning Ordinance and other ordinances, however no other accessory building shall be erected, altered, placed or permitted to remain on the Real Estate.

If the Owner or a person in possession of the Real Estate shall violate or attempt to violate any of the limitations, restrictions, conditions or covenants herein, it shall be lawful for the Village of Brookfield, Illinois or any person, or persons, owning any real estate within the Village of Brookfield, Illinois affected thereby to prosecute any action at law or equity against the person or persons violating or attempting to violate any limitation, restriction, condition or covenant, either to prevent its violation or to recover damages for the violation. The failure of the Village of Brookfield, Illinois or any land owner to enforce any limitation, restriction, condition or covenant herein contained shall in no event be deemed a waiver of the right to do so thereafter as to the same breach or as to one occurring prior or subsequent thereto.

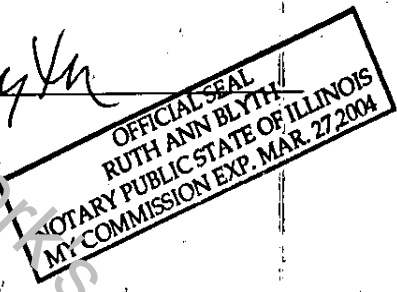
