3. That all notices required by law in connection with this proceeding have been properly mailed and published, and that all proceedings heretofore taken have been legally and properly taken, and that proper notice has been given as required by law of each of the steps taken before the Board of Local Improvements, and the Corporate Authorities of the Village, and in this Court.
