- 1. That the THORN CREEK BASIN SANITARYDISTRICT has treated and still treats the sewage from the following described real estate:

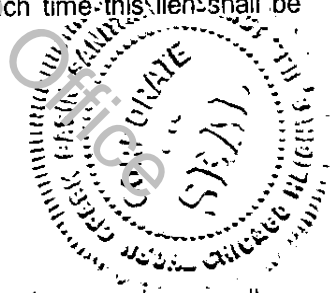

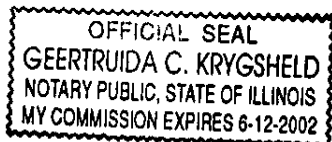
