- A maximum of ten percent (10%) of all the single family homes constructed on the Property by Declarant may be rented at any one time to a party or parties other than the owner of record of the particular lot on the Property in question. This is consistent with Paragraph 2 of Article V, "Development of the Property," of the Annexation and Development Agreement dated December 18, 1998, concerning the Property, as part of Ordinance Number 1047 entitled An Ordinance Authorizing the Execution of An Annexation and Development Agreement For the Property Commonly Known as University Place, approved by the Village of Hoffman Estates on January 4, 1999.
- 2. This Declaration may not be amended unless severity five percent (75%) of all the lot owners of the Property agree to do so, plus the Declarant if it owns any lots, and the Village, by a written amendment, properly executed and recorded with the office of the Recorder of Deeds of Cook County, Illinois.
- 3. This Declaration may be enforced by any lot owner of the Property, the Declarant, or the Village.
- 4. The provisions of this Declaration and the rights and obligations established thereby shall be deemed to be covenants running with the land and shall

insure to the benefit of, and be binding upon, each and all of the lot owners of the

Property, the Declarant and the Village and their respective heirs, representatives,

successors, assigns, purchasers, grantees and mortgagees. By the recording or acceptance

of a deed conveying any of the Property or any interest therein, or any ownership interest
