SUBCONTRACTOR'S CLAIM FOR LIEN

On March 22, 2000, Owner owned the property ("Property") described as follows:

Claimant is informed and believes that Contractor entered into a contract with Sears Roebuck & Co., a corporation ("Sears") for the construction of certain improvements at the Property ("Original Contract"), however Claimant has never received a copy cosuch Original Contract. Claimant is informed and believes that Owner knowingly permitted Contractor to furnish the labor, material and equipment required by the Original Contract.

On March 22, 2001, Contractor made a subcontract ("Subcontract") with the Claimant to furnish all labor, material and equipment necessary to complete all support slab demolition and related work for the improvements to be constructed at the Property for the sum of One Hundred Thirtynine Thousand Eight Hundred Dollars (\$139,800.00).

At the special instance and request of Contractor, the Claimant furnished extra and additional labor, materials and equipment to the Property having a value of Seven Hundred Twenty Thousand Two Hundred Fifty-seven Dollars and Eighty-seven Cents (\$720,257.87) ("Extras").

On May 11, 2001, the Claimant completed thereunder all that was required by the Subcontract to

be done, including Extras, by and with the knowledge and consent of the Owner.

Contractor is entitled to credits on account thereof of Seven Hundred Thirteen Thousand Six hundred and Two Dollars (\$713,602.00), leaving due, unpaid and owing to the Claimant, after allowing all credits, the sum of One Hundred Forty Six Thousand Four hundred Fifty-five Dollars and Eighty-seven Cents (\$146,455.87), plus interest, for which the Claimant claims a lien on the Property, on the moneys or other considerations due or to become due from Sears under the Original Contract against Contractor and Owner.
