### MEMORANDUM OF SIDE LETTER AGREEMENT

THIS MEMORANDUM OF SIDE LETTER AGREEMENT is made and entered into as of the loth day of October, 2001, by and between 95th & Stony I, L.L.C., an Illinois limited liability company ("Stony I"), having an address c/o U.S. Equities Realty, Inc., 20 North Michigan Avenue, Suite 200, Chicago, Illinois 60602, 95th & Stony II, L.L.C., an Illinois limited liability company ("Stony II"), having an address c/o U.S. Equities Realty, Inc., 20 North Michigan Avenue, Suite 200, Chicago, Illinois 60602 and LaSalle Bank National Association, a national banking association, having an address c/o AJSN AMRO North America, Inc., 135 S. LaSalle Street, Suite 3400, Chicago, Illinois 60603 ("Tenant").

#### WITNESSETH:

- 1. Stony I is the fee simple owner of that certain real property situated in the City of Chicago, Cook County, Illinois, legally described in Exhibit A attached hereto, and referred to herein as the "Shopping Center"; provided, however, 95<sup>th</sup> & Stony 1 is not the owner of Lot 4 therein.
- 2. Stony II is the fee simple owner of that certain real property situated in City of Chicago, Cook County, Illinois, which property is located within the Shopping Center, legally described in Exhibit B attached hereto and referred to herein as "Lot 4".
- 3. Stony II currently leases Lot 4 to Tenant pursuant to that certain Ground Lease Agreement dated March 13, 2000, as amended by First Amendment to Ground Lease Agreement dated as of the date hereof (the lease and all amendments thereto are collectively referred to herein as the "LaSalle Lease"). References herein to Tenant shall mean Tenant or its affiliates, subsidiaries, successors or assigns, as may be permitted under the LaSalle Lease.
- 4. Stony I and Stony II have entered into a Reciprocal Easement Agreement dated as of the date hereof (the "REA"). The REA provides for the maintenance of common areas within the Shopping Center, grants certain rights to Tenant and imposes certain obligations on Stony I.



- 5. Stony I, Stony II and Tenant have entered into a side letter agreement dated as of the date hereof (the "Agreement"), which Agreement modifies certain provisions of the REA.
- 6. This Memorandum of Side Letter Agreement is being executed and recorded in order to give notice of the existence of the Side Letter Agreement and the rights and other matters contained therein.

IN WITNESS WHEREOF, Landlord and Tenant have executed this Memorandum of Lease as of the day and year first above written.
