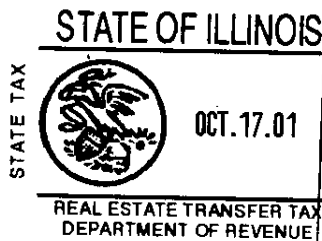
Units 420 and U169 in Clinton Complex Condominium as delineated on a survey of the following described real estate:
