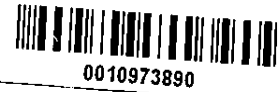

Towne Place West Condominium Association, an Illinois not-for-profit corporation, hereby files a Claim for Lien against Deborah L. Karakouris of the County of Cook, Illinois, and states as follows:

As of the date hereof, the said debtor was the owner of the following land, to wit:

Unit 18-141-B-2874 in Towne Place West Condominium, Schaumburg, IL, as delineated on a survey of the following described real estate: Towne Place Unit 6, being a subdivision out of the East half of Section 24, Township 41 North, Range 9, East of the Third Principal Meridian, in Cook County, Illinois, which survey is attached as Exhibit "A" to the Declaration of Condominium Ownership, recorded in Office of Recorder of Deeds of Cook County, Illinois, on May 15, 1991, as Document 91233253 together with a percentage of the common elements appurtenant to said Unit, as set forth in said Declaration as amended from time to time, which percentage shall automatically change in accordance with the amended Declarations as same are filed of record, in Cook County, Illinois,

and commonly known as 2874 Fremont Court, Schaumburg, IL 60193.

That said property is subject to a Declaration of Condominium Ownership recorded in the office of the Recorder of Deeds of Cook County, Illinois as Document No. 91233253. Said Declaration provides for the creation of a lien for the annual assessment or charges of the Towne Place West Condominium Association and the special assessment for capital improvements, together with interest, costs and reasonable attorney's fees necessary for said collection.

That as of the date hereof, the assessment due, unpaid and owing to the claimant on account, after allowing all credits with interest, costs and attorneys fees, the claimant claims a lien on said land in the sum of \$1,649.35, which sum will increase with the levy of future assessments, costs and fees of collection, all of which must be satisfied prior to any release of this lien.
