5. Property Insurance. Borrower shall keep the improvements now existing or hereafter erected on the Property insured against loss by fire, hazards included within the term "extended coverage," and any other hazards including, but not limited to, earthquakes and floods, for which Lender requires insurance. This insurance shall be maintained in the amounts (including deductible levels) and for the periods that Lender requires. What Lender requires pursuant to the preceding sentences can change during the term of the Loan. The insurance carrier providing the insurance shall be chosen by Borrower subject to Lender's right to disapprove Borrower's choice, which right shall not be exercised unreasonably. If Borrower abandons the Property, Lender may file, negotiate and settle any available insurance claim and related matters. If Borrower does not respond within 30 days to a notice from Lender that the insurance carrier has offered to settle a claim, then Lender may negotiate and settle the claim. The 30-day period will begin when the notice is given. In either event, or if Lender acquires the Property under Section 22 or otherwise, Borrower hereby assigns to Lender (a) Borrower's rights to any insurance proceeds in an amount not to exceed the amounts unpaid under the Note or this Security Instrument, and (b) any other of Borrower's rights (other than the right to any refund of unearned premiums paid by Borrower) under all insurance policies covering the Property, insofar as such rights are applicable to the coverage of the Property. Lender may use the insurance proceeds either to repair or restore the Property or to pay are un ts unpaid under the Note or this Security Instrument, whether or not then due.

- 6. Occ. pancy. Borrower shall occupy, establish, and use the Property as Borrower's principal residence within 60 days after the execution of this Security Instrument and shall continue to occupy the Property as Bor ower's principal residence for at least one year after the date of occupancy, unless Lender otherwise agrees in riting, which consent shall not be unreasonably withheld, or unless extenuating circumstances exist which are beyond Borrower's control.
- 7. Preservation, Maintenance and Protection of the Property; Inspections. Borrower shall not destroy, damage or impair the Property, allow the Property to deteriorate or commit waste on the Property. Whether or not Borrower is residing in the Property, Borrower shall maintain the Property in order to prevent the Property from deteriorating or decreasing in value due to its condition. Unless it is determined pursuant to Section 5 that repair or restoration is not economically feasible, Borrower shall promptly repair the Property if damage 1 to avoid further deterioration or damage. If insurance or condemnation proceeds are paid in connection with damage to, or the taking of, the Property, Borrower shall be responsible for repairing or restoring the Property only if Lender has released proceeds for such purposes. Lender may disburse proceeds for the repairs and restoration in a single payment or in a series of progress payments as the work is completed. These agreements may require the mortgage insurer to make payments using any source of funds that the mortgage insurer may have available (which may include funds obtained f.c., Mortgage Insurance premiums).

As a result of these agreements, Lender, any purchaser of the Note, another insurer, any reinsurer, any other entity, or any affiliate of any of the foregoing, may receive (directly or indirectly) amounts that derive from (or might be characterized as) a portion of Borrower's payments for Mortgage Insurance, in exchange for sharing or modifying the mortgage insurer's risk, or reducing losses. If such agreement provides that an affiliate of Lender takes a share of the insurer's risk in exchange for a share of the premiums paid to the insurer, the arrangement is often termed "captive reinsurance." Further:

(a) Any such agreements will not affect the amounts that Borrower has agreed to pay for Mortgage Insurance, or any other terms of the Loan. Such agreements will not increase the amount

Borrower will owe for Mortgage Insurance, and they will not entitle Borrower to any refund.

(b) Any such agreements will not affect the rights Borrower has - if any - with respect to the Mortgage Insurance under the Homeowners Protection Act of 1998 or any other law. These rights may include the right to receive certain disclosures, to request and obtain cancellation of the Mortgage Insurance, to have the Mortgage Insurance terminated automatically, and/or to receive a refund of any Mortgage Insurance premiums that were unearned at the time of such cancellation or termination.

11. Assignment of Miscellaneous Proceeds; Forfeiture. All Miscellaneous Proceeds are hereby

#### ADJUSTABLE RATE RIDER

(1 Month LIBOR Index - Payment and Rate Caps)

THIS ADJUSTABLE RATE RIDER is made this 12th day of October, 2001 and is incorporated into and shall be deemed to amend and supplement the Mortgage, Deed of Trust or Security Deed (the "Security Instrument") of the same date given by the undersigned (the "Borrower") to secure Borrower's Adjustable Rate Note (the "Note") to Chavy Chase Bank, P.S.B.

(the "Lender") of the same date and covering the property described in the Security Instrument and located at:

THIS KEER CONTAINS PROVISIONS ALLOWING FOR CHANGES IN MY INTEREST RATE AND MY MONTHLY PAYMENT. THE MONTHLY PAYMENT INCREASES COULD RESULT IN A PRINCIPAL BALANCE OF UP TO 110% OF THE ORIGINAL AMOUNT. THE BORROWER'S INTEREST RATE CAN NEVER EXCEED THAT LIMIT STATED IN THE NOTE.

ADDITIONAL COVENANTS. In addition to the covenants and agreements made in the Security Instrument, dorrower and Lender further covenant and agree as follows:

#### 1. INTEREST RATE

Interest will be charged on the unpaid principal until the full amount of principal has been paid. I will pay interest at the yearly rate of \$.650 % ("Initial Interest Rate") until the first Interest Rate Change Date. Thereafter, the interest rate will be subject to change in accordance with Section 2 of this Rider.

Each date on which my interest rate could change is called an "Interest Rate Change Date". The first day of each 36-month period described above is called a "Modification Date."

#### (B) The Index

Beginning with the first Interest Rate Change Date, my interest rate will be based on an Index. The "Index" is the one-month London Interbank Offered Rate (LIBOR) as published in the Wall Street Journal. The most recent Index figure available as of the first business day of the month immediately preceding the month in which the Interest Rate Change Date occurs is called the "Current index."

If the Index or any Index previously substituted under this Section is no longer a calleble, or is otherwise unpublished, the Note Holder may choose a new Index and a new Margin to result in a rate similar to the rate in effect at that time which is based upon comparable information. The Note Holder will give me notice of the oppice.

#### (C) Interest Rate Campe

Before each Interest Rate Change Date, the Note Holder will calculate my new interest rate by adding 3 and 000/1000 percentage points (3.000 %) ("Margin") to the Charest Index. Subject to the limits stated in Section 2(D) below, this amount will be my new interest rate until the next Interest Rate Change Date.

#### (D) Interest Rate Limit

My interest rate cannot increase or decrease more than 1/2 of 1% per month under the Monthly Interest Rate Change Option, 1.001% per 6-month period under the Semi-Annual Interest Rate Change Option, or 2.00% per year under the Annual Interest Rate Change Option, and in any event, over the term of the loan, my interest rate cannot increase more than 5.000% over the Initial Interest Rate.

#### (E) Payment Amounts and Change Dates

There are three versions to this loan program. The amount of my monthly payment will be determined by the version of the program under which my loan was made.

If, under the requirements set forth in the Note, I qualify at loan closing and continue to qualify on each monthly payment due date, I may, under one version of the program, elect each month to make a payment consisting of (i) a fully amortizing payment that would be sufficient to repay the unpaid principal balance of the loan in full on the maturity date in substantially equal installments at the interest rate then applicable under the terms of my loan ("Full Psyment"), (ii) a minimum monthly payment that would be sufficient to repay the unpaid principal balance of my loan in full on the maturity date in substantially equal installments at an interest rate of 2.000 % per annum below the interest rate then applicable under the terms of my loan ("Minimum Monthly Payment"), or (iii) interest only on the unpaid principal balance of my loan, at the interest rate then applicable under the terms of my loan ("Interest Only Payright"). I will be notified of any change in my monthly payment in writing at least 25 days before the due date of the payment, which notice will describe each such monthly payment option applicable to my loan. I may then, depending upon the version of the loan program, choose which amount I will pay, subject to Section 2(F) below.

#### (F) Monthly Payment Limitation

If my loan program allows me to select the Minimum Monthly Payment, my payment will automatically change to a Full Payment if at any time the unpaid principal balance of my loan reaches 110% of the principal amount I originally borrowed. The Full Payment amount will be required each month unless I re-qualify on a Modification Date. In any event on the 5th Modification Date, my payment will permanently change to the Full Payment.

(G) Changes in the Unpaid Principal Due to Negative Amortization

For each month that the monthly payment is less than the interest portion due, the Note Holder will subtract the monthly payment from the amount of the interest portion and will add the difference to my unpaid principal balance, and interest will accrue on the amount of this difference at the current interest rate.

(H) Limit on the Unpaid Principal; Increased Monthly Payment

My unpaid principal may never exceed a maximum amount equal to 110% of the principal amount originally borrowed, and this would only occur under the version of the loan program allowing me to elect Minimum Monthly Payments. If that occurs, I must then begin paying Full Payments until the maturity date, unless I reduce principal such that this amount is not exceeded.

(I) Required Full Monthly Payment (Under Versions of the Program Allowing Payment Options)

the terms of the Note, I will be required to make Full Payments until the maturity data. In any event, on the 5th Modification Date, my payment will permanently change to the Full Payment.

(J) Fallure to Make Acjustments

If for any reason the Note Holder fails to make an adjustment to the interest rate or payment amount as discribed in this Rider, regardless of any notice requirement, I agree that Note Holder, may, upon discovery of such failure, make the adjustment as if it had been made on time. I also agree not to hold Note Holder responsible for any damages to me which may result from the Note Holder's failure to make the adjustment and to let the Note Holder, at its option, apply any excess monies which I may have paid to partial prepayment of unpaid principal.

3. TRANSFER OF THE PROPERTY OR A BENEFICIAL INTEREST IN BORROWER

Covenant 17 of the Security Instrument is amended to read as follows:

Transfer of the Property or a Beneficial Interest in Borrower. If all c. any part of the Property or any interest in it is sold or transferred (or if a beneficial interest in Borrower is sold or transferred and Borrower is not a natural person) without Lender's prior written consent, Lender may, at its option, require immediate payment in full of all sums secured by this Security Instrument.

Lender also shall not exercise this option if: (a) Borrower causes to be submitted to Lender information required by Lender to evaluate the intended transferce as if a new loan were being made to the transferce; (b) Lender reasonably determines that Lender's security will not be impaired by the loan assumption and that the risk of a breach of any covenant or agreement in this Security Instrument or other obligations related to the Note or other loan document is acceptable to Lender; (c) Assuming party executes an Assumption agreement acceptable to Lender at its sole choice and discretion; and (d) payment of Assumption Fee if requested by Lender.

To the extent permitted by applicable law, Lender may charge a reasonable fer as a condition to Lender's consent to the loan assumption. Lender may also require the transferee to sign an Assumption Agreement that is acceptable to Lender and that obligates the transferee to keep all the promises and agreements made in the Note and in this Security Instrument. If Lender exercises the option to require immediate payment in full, Lender shall give Borrower notice of acceleration. The notice shall provide a period of not less than 30 days from the date the notice is delivered or mailed within which Borrower must pay in sum; secured by this Security Instrument. If the Borrower fails to pay these sum prior to the expiration of this period, Lender may invoke any remedies permitted by this Security Instrument without further notice or demand on Borrower.

BY SIGNING BELOW, Borrower accepts and agrees to the terms and covenants contained in this Adjustable Rate Rider. Borrower agrees to execute any document necessary to reform this Agreement to accurately reflect the terms of the Agreement between Borrower and Beneficiary, or if the original Note, Trust Deed or other document is lost, mutilated or destroyed, to execute said documents which will have the effect of the original for all said purposes.
