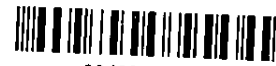

Dear Sirs:

The purpose of this letter is to document and record a change to the window and window cap color scheme that was approved by a vote of the unit owners of the 925-929 West Margate Terrace Condominium Association.

The result of the vote is that the color scheme of the building windows at 925-929 West Margate Terrace, Chicago, IL, 60640 will be as follows:

- the windows and window caps on the second, third, and fourth floors on the south (alley) side of the building will be white
- the windows and window caps on the second, third, and fourth floors on the east and west sides of the building up to but not including the dining room windows will be white
- the windows and window caps on the dining room windows will be brown
- the windows and window caps on the first floor on the south, east, and west sides of the building will be brown
- the windows on the living rooms and sun porches in the front (north) side of the building will be brown and will not have window caps.

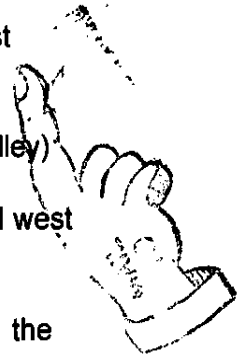
All doors on the south, east, and west sides of the building will be brown.
