## EXHIBIT "A"

Muirfield Homeowner's Association Article 4 - Corporate Purpose

Administration, maintenance and operation of the "Maintenance Area" as defined in the Declaration of Covenants, Conditions, Restrictions and Easements for the Muirfield Subdivision recorded February 19, 1998 as Document No. 98131815 in Cook County, Illinois, together with any amendments thereto (herein the "Declaration"); administration and enforcement of the provisions of the Declaration; and, to carry on any business whatsoever that 'ni's corporation may deem proper or convenient in connection with any of the foregoing purposes or otherwise, or that it may deem calculated, directly or indirectly, to improve the interests of this corporation, and to do all things specified in "The General Not for Profit Corporation Act of 1986", and to have and to exercise all powers conferred by the laws of the State of Illinois on corporations formed under the laws pursuant to which and under which this corporation is formed, as such laws are now in effect or may at any time increafter be amended, and to do any and all things hereinabove set forth to the same extent and as fully as natural persons might or could do, either alone or in connection with citier persons, firms, associations, or corporations.

The foregoing statement of purposes shall be construed as a statement of both purposes and powers, shall be liberally construed in sid of the powers of this corporation, and the powers and purposes stated in each clause shall, except where otherwise stated, be in nowise limited or restricted by any term or provision of any other clause, and shall be regarded not only as independent purposes, but the purposes and powers stated shall be construed distributively as each object expressed, and the enumeration as to specific powers shall not be construed as to innit in any manner the aforesaid general powers, but are in furtherance of, and in addition to and not in limitation of said general powers.
