4. On or about Sep. 2001, Claimant completed all of the Work under the terms of and in accordance with the Contract, in that Claimant supplied all labor and materials necessary for performance of its duties under the Contract for the improvements to the Property.
5. All of the labor and materials furnished and delivered by Claimant were furnished to and used in connection with the improvement of the Property, and the last of

such labor and materials was furnished, delivered and performed, and the work contemplated under the Contract completed, on or about Sep. 2001.

- 6. There is now justly due and owing the Claimant after allowing to the Owners' Agent all credits, deductions and offsets, the sum of sixty four thous. five hun. (\$64,500) plus interest at the rate specified in the Illinois Mechanics Lien Act.

Claimant now claims a lien on the above-described Property, and on all of the improvements thereon, against the Owner, the Owner's Agent and all persons interested therein for sixty four th. five h. (\$64,500) plus interest at the rate specified in the Illinois Mechanics Lien Act, as well as court costs and attorney fees
