IT IS FURTHER ORDERED that the scheduled case management date of _____, be stricken and Plaintiff is excused from appearance at that time.

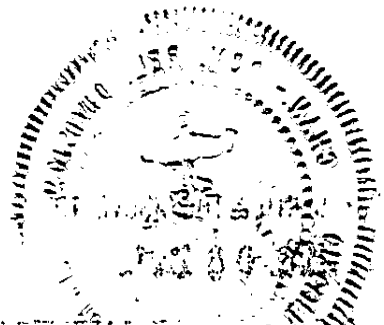
