MEMORANDUM OF AGREEMENT



This Memorandum of Agreement is entered into on this ______ day of _______, 200_____, by and Sprint Spectrum, L.P. & Delaware limited partnership, d/b/a Sprint PCS, with an office at 9801 West Higgins Road, Suite 540, Rosemont, D. 60018, (hereinafter referred to as "Licensor") and Nextel West Corp., a Delaware corporation, d/b/a Nextel Communications, with an office at 400 West Grand Avenue, Elmhurst, IL 60126 (hereinafter referred to as "Licensee").
