I devise and bequeath my residuary estate, all my property, to Vilma L. Kohnke, my wife, unless the (Vilma L. Kohnke) fails to survive me by 45 days. In that event, my entire residuary estate shall be shared equally between my three sons, as listed above. To achieve an esate settlement in the case of my death and my wife's death in 45 days or less, I nominate my oldest son, Rudi Scott Kohnke, as Executor, to serve without bond. I direct that my Executor take all actions legally permissible to have the probate of my estate done as simply as possible, including filing a petition in the appropriate court for the independent administration of my estate
