MODIFICATION OF MORTGAGE

THIS MODIFICATION OF MORTGAGE dated August 10, 2001, is made and executed between Clarke Construction, LLC, whose address is 9314 S. Spaulding, Evergreen Park, IL 60805 (referred to below as "Grantor") and Pullman Bank and Trust, whose address is 6100 N. Northwest Highway, Chicago, IL 60631 (referred to below as "Lender").

This waiver applies not only to any initial extension or modification, but also to all such subsequent actions.

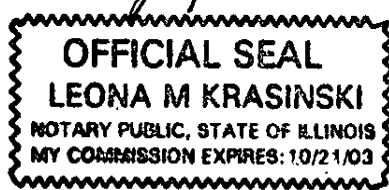
