This is a Partial Release of the Mortgage, and the lien of the Mortgage shall continue in full force and effect as to all of the Mortgaged Property not released hereby.



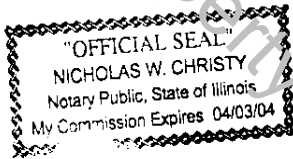
