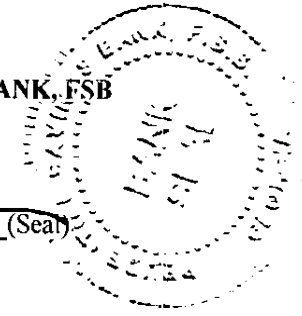
DISCHARGE OF MORTGAGE
