MEMORANDUM OF JUDGMENT

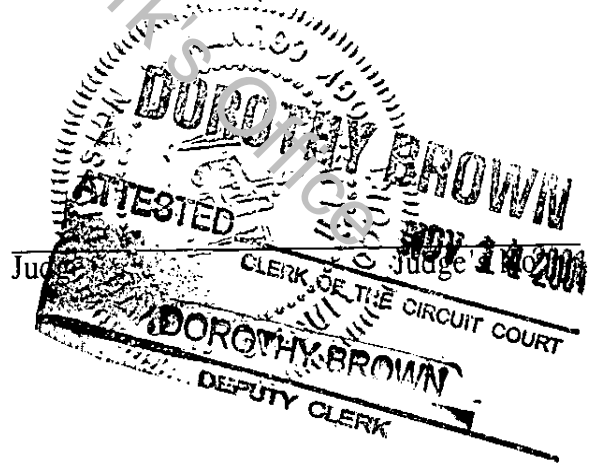
On October 10, 2001, judgment was entered in this court

principal amount of \$19,047.50 plus interest of \$5,633 for a total of \$24,680.

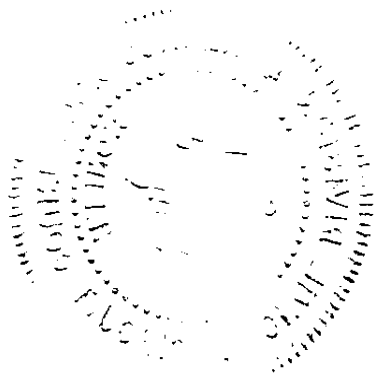
