MEMORANDUM OF LEASE

This Memorandum of Lease is made with respect to a Lease dated October 25, 2001, ("Lease") by and between Firststar Bank N.A., not personally but as Trustee under Trust Agreement dated October 10, 2001 and known as Trust No. 7504 ("Trustee") and St. George Hotel, L.L.C., an Illinois limited liability company ("St. George") (Trustee and St. George are referred herein together as "Landlord") and HRH Chicago, LLC, an Illinois limited liability company ("Tenant").

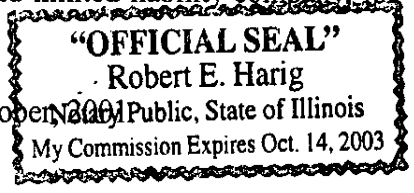

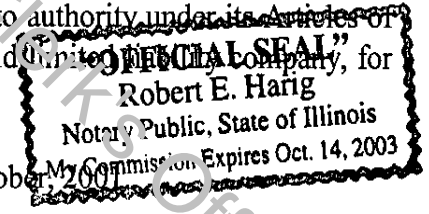

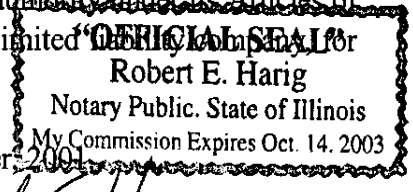
