

3. Notice was published in the Chicago Sun-Times in Chicago, Illinois, from MARCH 24, 2001 through MARCH 26, 2001.



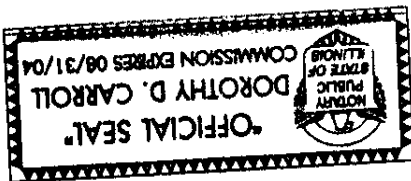
