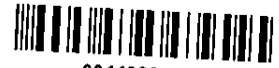

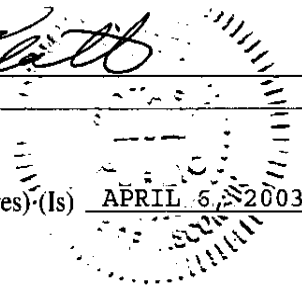

LEGAL DESCRIPTION

3344 LINCOLN
FRANKLIN PARK, IL 60131

That part of Lots 20, 21, 22, 23, 24, 25 and 26 in Block 58 in Third Addition to Franklin Park, a subdivision in the Southwest 1/4 of section 21, Township 40 North, Range 12, East of the Third Principal Meridian, in Cook County, Illinois, lying Easterly of a line described as follows:

Beginning at a point on the South Line of said lot 26, said point being 15.3 feet East of the Southwest corner of said lot 26; thence Northerly along a straight line to a point in the North Line of said lot 20, said point being 26.2 feet East of the Northwest corner of said lot 20; also, that part of lots 27, 28 and 29 in Block 58 aforesaid lying Easterly of a line described as follows:

Beginning at a point in the South Line of said lot 29, said point being 10.6 feet East of the Southwest corner of said lot 29; thence Northeasterly along a straight line to a point in the North line of said lot 27, said point being 15.3 feet East of the Northwest corner of said lot 27; (excepting from the aforesaid part of lots 24, 25, 26, 27, 28 and 29 that part thereof described as follows:

Beginning at a point in the South line of said lot 29, said point being 10.6 feet East of the Southwest corner of said lot 29; thence Northeasterly along a straight line which if extended would intersect the South Line of Lot 21 in Block 58, aforesaid, 23.1 feet East of the Southwest corner of said lot 21, a distance of 150.3 feet, more or less, to a point 20 feet East of the West line of said lot 24 and 150.0 feet North of said South line of said lot 29; thence South along a line parallel and distant 20 feet East of the West line of Lots 24 through 29 inclusive, a distance of 150.0 feet to the South line of lot 29; thence West along said South Line of Lot 29, a distance of 9.4 feet to the point of beginning)
