THIS INDENTURE, made this \(\begin{align*} \) day of October, 2001, between the VILLAGE OF PALATINE, an Illinois home rule municipal corporation created and existing under and by virtue of the laws of the Sate of Illinois and duly authorized to transact business in the State of Illinois, party to the first part, and GROVES OF PALATINE LLC, an Illinois limited liability company, grantee, WITNESSETH, that the grantor, for and in consideration of the sum of Ten and NO/100 Dollars (\$10.00) and other good and valuable consideration in hand paid by the grantee, the receipt whereof is hereby acl nowledged, by these presents does REMISE, RELEASE, ALIEN AND CONVEY unto the grantee, and to its successors and assigns, FOREVER, all the following described real estate, situated in the County of Cook, and State of Illinois known as described as follows, to wit:

See Exhibit A attached hereto and made a part hereof.

Together with all and singular the hereditaments and appurtenance thereunto belonging, or in anywise appertaining, and the reversion and reversions, remainder and remainders, rents, issues and profits thereof, and all the estate, right, title, interest, claim or demand whatsoever, of the grantor, either in law or equity, of, in and to the above described premises, with the hereditaments and appurtenances. TO HAVE AND TO HOLD the said premises as above described, with the appurtenances, unto the grantee, its successors and assigns forever, subject to those matters disclosed at Exhibit B attached hereto and made a part hereof.

And the grantor, for itself, and its successors, does covenant, promise and agree to and with the grantee, its successors and assigns, that it has not done or suffered to be done, anything whe eby the said premises hereby granted are, or may be, in any manner incumbered or charged, except as herein recited; and that the said premises against all persons lawfully claiming, or to claim the same, by, through or under it, it WILL WARRANT AND DEFEND, subject to those matters set forth in Exhibit B attached hereto and made a part hereof.
