I, the undersigned, do hereby certify that a Notice of Appeal for the above stated case was filed with the Circuit Court of Cook County on the 1st day of November 2001 following the Circuit Court Judgment entered against Sag Bridge Enterprises on October 5, 2001. The property affected by said cause is described as follows:

Parcel #1

That part of the East 1/2 of the Northeast 1/4 of section 23, Township 37 North, Range 11, East of the Third Principal Meridian, described as follows: Beginning at a point in the North line of said East 1/2 of the Northeast 1/4 which is 700 feet East of the Northwest Corner of said East 1/2 of the Northeast 1/4; Thence East, along said line, a distance of 350 feet; thence Southerly, along a line which is parallel with the West line of said East 1/2 of the Northeast 1/4 for 709.45 feet, to the Center of a Road (Archer Avenue); thence Southwestwardly along the center of said road, for a distance of 478.17 feet, more or less, to a point which is 700 feet East of the West line of said East 1/2 of the Northeast 1/4; thence North along a line which is parallel with said West line of the East 1/2 of the Northeast 1/4 for a distance of 1,035.29 feet, to the place of beginning, containing 7.01 acres, more or less, situated in the Township of Lemont, County of Cook, and State of Illinois.

Parcel #2

A parcel of land in the East $\frac{1}{2}$ of the Northeast $\frac{1}{4}$ of Section 23, Township 37 North, Range 11, East of the Third Principal Meridian, bounded and described as follows: Measure along the North section line from the Northwest corner of the East $\frac{1}{2}$ of the Northeast $\frac{1}{4}$ of said section, a distance of 150 feet to the place of beginning; thence continue along said section line, a distance of 250 feet; thence South along a line parallel with and 400 feet East of the West line of the East $\frac{1}{2}$ of the Northeast $\frac{1}{4}$ of said section, 1315.21 feet to the center of the public highway known as Archer Avenue, or State Aide Route 85; thence Southwest along the center line of said public highway, a distance of 341.65 feet, more or less, to a point 150 Feet East of the West line of the East $\frac{1}{2}$ of the Northeast $\frac{1}{4}$ of said section measured at right angles thereon, which is 1,548.07 feet South of the place of beginning; thence North to the place of beginning, containing 8.22 acres, more or less, situated in the Township of Lement, County of Cook, and State of Illinois.

Parcel #3

That Part of the East $\frac{1}{2}$ of the Northeast $\frac{1}{4}$ of Section 23, Township 37 North, Range 11, East of the Third Principal Meridian, described as follows: Commencing at a point in the North line of said quarter section at a point 400 feet East of the Northwest corner of the East $\frac{1}{2}$ of the Northeast $\frac{1}{4}$ of said section; thence continuing East along said section line, a distance of 300 feet; thence South along a line parallel with and 700 feet East of the West line of the East $\frac{1}{2}$ of the Northeast $\frac{1}{4}$ of said section to the center of a public highway known as Archer Avenue or State Aid Road, Route Number 85; thence Southwesterly along the center line of the public road, a distance of 409.98 feet, more or less, to a point 400 feet East of the West Line of the East $\frac{1}{2}$ of the Northeast $\frac{1}{4}$ of said section, measured at right angles to said line, which point is 1,314.99 feet South of the place of beginning; thence North to the place of beginning, situated in the Township of Lement, County of Cook, and State of Illinois.

Parcel #4

The East 2 acres of Lot 3 (except the West 20 feet thereof) in Doolin and Kirk's resubdivision of the East 404.7 feet of the Southwest $\frac{1}{4}$ of the Southeast $\frac{1}{4}$ and of the Southeast $\frac{1}{4}$ of the Southeast $\frac{1}{4}$ of section 14, Township 37 North, Range 11, East of the Third Principal Meridian, (except lots 1 to 5 of Boe's subdivision of part thereof) in Cook County, Illinois.

Parcel #5

Lot 5 (Except the East 101.94 feet Thereof) in Christian Boe's subdivision in the Southeast $\frac{1}{2}$ of Section 14, Township 37 North, Range 11, East of the Third Principal Meridian, in Cook County, Illinois.


