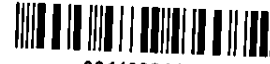

## Assignment of Mortgage

The term "Lender" as used in the Mortgage, shall be hereafter deemed to mean Philip and Darleen Bucaro (as assignee of Universal Securities and Lending Services, Inc.).

2. Assignor agrees that at any time and from time to time, upon the written request of the Assignee, it will promptly and duly execute and deliver any and all such further instruments and documents as are reasonably necessary to effectuate this assignment.

Assignor warrants and represents to Assignee that: (a) Assignor has full right, power, and authority to enter into this Assignment; and (b) Assignor's execution and delivery of this Assignment, and its assignment and transfer of the Mortgage to Assignee, constitutes the legal, binding and enforceable obligations of Assignor.

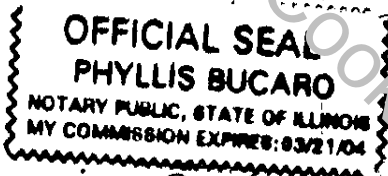

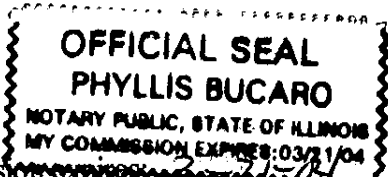
