WHEREAS, Richard J. Roddewig And Noreen J. Roddewig, Husband And Wife ("Property Owner") executed a Mortgage or Deed of Trust (hereinafter the "Junior Mortgage") in favor of Subordinating Lender dated June 23, 1997 and which was recorded in the Office of the Recorder of Cook County County, Illinois, on June 24, 1997 as Document Number 97452834 encumbering the real estate and all buildings, structures, fixtures and improvements thereon (the "Premises") which has the street address of 4536 Grand Avenue, Western Springs, Illinois 60558 and is legally described on Exhibit A attached hereto and made a part hereof; and



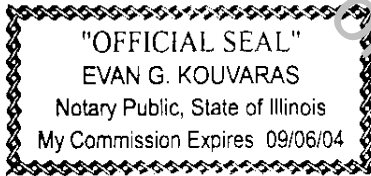
