SUBCONTRACTOR'S CLAIM FOR LIEN

THE CLAIMANT, BECK RAMM BRICK COMPANY ("Claimant"), whose business address is 821 Seegers Road, Des Plaines, Illinois, makes the following statement and claims a mechanic's lien, pursuant to the provisions of the Illinois Mechanic's Lien Act, 770 ILCS 60/1 et seq., as amended from time to time, against ETHICAL HUMANIST SOCIETY OF CHICAGO, ("Owner"), and states:

1. The subject property is commonly known as 7574 Lincoln Avenue, Skokie, Illinois and legally described in Exhibit "A" attached hereto ("Property").
2. Claimant was employed by SABRIS DEVELOPMENT CORP. ("Contractor"), as Owner's agent or with the knowing permission of the Owner of the Property, to furnish masonry materials and stone for the construction of improvements upon the Property.
3. Claimant has provided all masonry materials and stone ordered by the Contractor, all of which were furnished, delivered to, accepted and incorporated in the Property as valuable

improvements thereof. The last of the masonry materials and stone were so provided and furnished by Claimant on September 7, 2001.

4. After allowing for any and all just credits, there remains due, unpaid and owing to Claimant for the masonry materials and stone so provided and furnished by Claimant, the total sum of FIVE HUNDRED THIRTY NINE AND 81/100 DOLLARS (\$539.81).

5. Claimant now claims a lien upon the Property, and all improvements located thereon, and against all persons interested therein, for the sum of FIVE HUNDRED THIRTY NINE AND 81/100 DOLLARS (\$539.81), together with interest thereon as provided by statute.

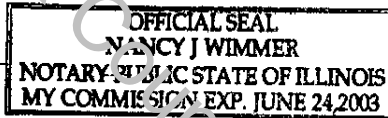
