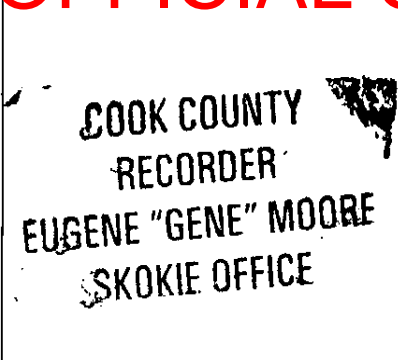


**CONTRACTOR'S

That on January 10, 2001, the claimant made a contract with said owner to supply labor and material for the construction of a demising wall between master bedroom and master bath, the remodeling of 2 bathrooms, new flooring in 3 rooms, replacement of 1 electric service feed line, new window coverings throughout home and other general renovations for the sum of \$85,000.00 and on September 15, 2001 work to the value of \$85,000.00 was completed thereunder

That at the special instance and request of said owner the claimant furnished extra and additional materials and extra and additional labor on said premises of the value of \$1,500.00 and completed same on October 19, 2001.

That said owner is entitled to credits on account thereof as follows to-wit: \$2,500.00

Leaving due, unpaid and owing to the claimant, after allowing all credits, the balance of \$84,000 for which, with interest, the claimant claims a lien on said land and improvements.
