Payments are deemed received by Lender when received at the location designated in the Note or at such other location as may be designated by Lender in accordance with the notice provisions in Section 15. Lender may return any payment of partial payment if the payment is partial payment insufficient to bring the Loan current. Lender may accept any payment or partial payment at the time such payment is offered to Lender without waiver of any rights hereunder or prejudice to its rights to refuse such payment or partial payment in the future, but Lender is not obliged to apply such payments at the time such payments are accepted. If each Periodic Payment is applied as of its scheduled due date, then Lender need not pay interest on unpaid funds. Lender may hold such unpaid funds until Borrower makes payment to bring the Loan current. In the event of loss, Borrower shall give prompt notice to the insurance carrier and Lender. Lender may make proof of loss if not made promptly by Borrower. Unless Lender and Borrower otherwise agree in writing, any insurance proceeds, whether or not the underlying insurance was required by Lender, shall be applied to restoration of repair of the property, if the repair is economically feasible and Lender's security is not lessened. 
