THIS MORTGAGE IS DATED APRIL 28, 1999, between TIMOTHY J. GIBSON and LORI GIBSON, HUSBAND AD WIFE ,JOINT TENANTS, whose address is 11858 CHISHOLM (PAIL, ORLAND PARK, IL 60467 (referred to below as "Grantor"); and OLD KENT BANK, whose address is 10759 WEST 159TH ST., ORLAND PARK, IL 60467 (referred to below as "Lender").

GRANT OF MORTGAGE.
