MORTGAGE

THIS MORTGAGE IS DATED APRIL 28, 1999, between TIMOTHY J. GIBSON and LORI GIBSON, HUSBAND AND WIFE, JOINT TENANTS, whose address is 11858 CHISHOLM TRAIL, ORLAND PARK, IL 60467 (referred to below as "Grantor"); and OLD KENT BANK, whose address is 10759 WEST 159TH ST., ORLAND PARK, IL 60467 (referred to below as "Lender").

GRANT OF MORTGAGE. For valuable consideration, Grantor mortgages, warrants, and conveys to Lender all of Grantor's right, title, and interest in and to the following described real property, together with all existing or subsequently erected or affixed buildings, improvements and fixtures; all easements, rights of way, and appurtenances; all water, water rights, watercourses and ditch rights (including stock in utilities with ditch or irrigation rights); and all other rights, royalties, and profits relating to the real property, including without limitation all minerals, oil, gas, geothermal and similar matters, located in COOK County, State of Illinois (the "Real Property"):

LOT 17. IN ORLAND TRAILS, BEING A SUBDIVISION OF THE WEST HALF OF THE NORTHWEST QUARTER OF SECTION 6, TOWNSHIP 36 NORTH RANGE 12, EAST OF THE THIRD PRINCIPAL MERIDIAN IN COOK COUNTY ILLINOIS.
